UTU PAC contributes to qualified state and national political candidates, regardless of political affiliation.



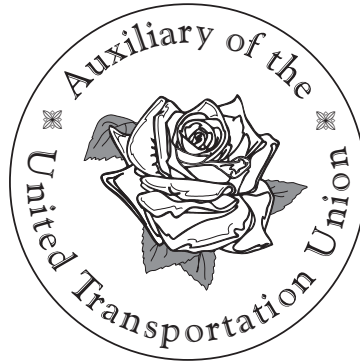
UTU PAC protects the interests of active and retired UTU and Auxiliary members and safeguards laws, working conditions and pension rights.
